UPDATED INFORMATION ON THE TIME LIMIT TO RESPOND TO NOTIFICATIONS OF PROVISIONAL REFUSAL AND ON THE WAY TO CALCULATE THEM

Document prepared by the International Bureau

1. The International Bureau prepared a document concerning notifications of provisional refusal for its discussion at the nineteenth session of the Working Group on the Legal Development of the Madrid System for the International Registration of Marks (hereinafter referred to as "the Working Group"), held in Geneva from November 15 to 17, 2021.¹

2. To supplement the aforementioned document, the International Bureau prepared an information document concerning the time limits to respond to notifications of provisional refusal and the ways in which they are calculated.²

3. This document has been prepared by the International Bureau to complement its document on provisional refusal³ for discussion at the twentieth session of the Working Group, and it contains updated information on the above-mentioned time limits and their calculation.

4. The International Bureau has extracted the updated information either from the replies to a questionnaire that it sent to the Offices of the Contracting Parties in April 2021, from the Madrid Member Profiles database, or from recently received notifications of provisional refusal.

5. When compiling and updating this information, the International Bureau noticed that some information is missing, as this has not been provided by Offices of some Contracting Parties. The Annex is marked "no information available" where this is the case.

6. In view of the above, delegations of the Contracting Parties are kindly invited to review the information presented in the Annex to this document and, where appropriate, provide the International Bureau with any necessary updates as soon as possible.

7. The International Bureau transmits a copy of the notification of provisional refusal to the holder attached to a letter from the International Bureau. This cover letter is in the language in which the holder has chosen to receive communications from the International Bureau. The International Bureau intends to set out the updated information concerning time limits and how those time limits are calculated in its cover letter to the holder. Following the information set out in this Annex, where the International Bureau has clear and verified information of the time limits provided by the Office concerned, the cover letter will reflect that information to alert the holder of the applicable time limits concerned. Those time limits would need to be cross-checked with the time limits set out in the actual notification.
