## PCDA/2/3 Annex I, page 2

The Second Session of the PCDA was held from June 26 to 30, 2006. The PCDA based its discussions on Annex 1 of document PCDA/1/6 Prov.2. The PCDA also took note of the proposal contained in document PCDA/2/2.

Bearing in mind the crucial importance of a Development Agenda for WIPO and taking into account the fruitful and positive discussions during its two sessions in February and June 2006, the PCDA recommends for the consideration of the General Assembly and its possible decision, that:

- 1) without prejudice to any proposals submitted during the IIM/PCDA process, the future discussions would consider and build upon the proposals which received emerging consensus support during the PCDA process, notably, those contained in the Annex;
- 2) intergovernmental discussions on a proposed Development Agenda for WIPO would be continued in an appropriate forum or body of WIPO;
- 3) the choice of the forum or body, the frequency and duration of the sessions of the said forum or body, as well as facilitating the participation of developing and transition countries would be determined, bearing in mind budgetary implications;
- 4) the future discussions would be structured along the following six thematic clusters, which were identified during the PCDA process:
  - A. Technical Assistance and Capacity Building
  - B. Norm-Setting, Flexibilities, Public Policy and Public Domain
  - C. Technology Transfer, Information and Communication Technology (ICT) and Access to Knowledge
  - D. Assessments, Evaluation and Impact Studies
  - E. Institutional Matters, including Mandate and Governance
  - F. Other Issues
- 5) the future discussions would continue to deal with all the proposals, which had been taken up by the PCDA, and listed in Annex 1 of document PCDA/1/6 Prov 2;
- 6) the outcome of the future discussions, with recommendations, if any, would be reported to the General Assembly at its September 2007 session.
