European Union





History

- Initial proposal in 1993
- Directive to EU Members States 12 October 1998
- Directive implementation deadline 28
 October 2001
- Regulation commenced 6 March 2002
- OHIM accepted filings from 1 January 2003



Regulations: directly applicable throughout the EU

Directives: require members states to comply by enacting national legislation



Design

- "The appearance of the whole or part of a product resulting from the features of, in particular, the lines, contours, colours, shapes, textures and /or materials of the product and/or its ornamentation"
- Includes parts of a complex product (if visible whilst the product is in use)
- Logos, font, packaging, but not computer programmes
- No test of ornamentality / aesthetics




























Not Protected

- Designs solely dictates by their technical function
- Interconnection
- Designs contrary to public policy/morality
- Computer programs
- Spare parts (at Community level)



Registered Community Design

- **Up to 25 years** (5+5+5+5+5)
- Protects any design which does not produce a different overall impression on the informed user
- Exclusive right to make, offer, put on the market, import, export or use of a product in which the design is incorporated or to which it is applied
- Protects against any use, not just copying

Unregistered Community Designs

- No requirement for registration
- Lasts for three years
- Only protects from copying, not independent creation




Advantages

- Inexpensive (approximately €500, less if more filed at once)
- Quick registered within 2 months
- No examination on relative grounds
- **EU-wide injunctions against infringers**



RCD Filings at OHIM





Validity

"New" – differs in material details from designs previously made available to the public

"Individual Character" – overall impression produced on the informed user differs from impression produced by any design made available to the public



Many RCDs are likely to be invalid










Worldwide Novelty

"Made available to the public" – published exhibited, used in trade or otherwise disclosed except where those events could not reasonably become known in the normal course of business to those specialized in the sector, operating in the EEA




