Sampling Frame

● Annual Granted Chinese Patents(2008-2013)

Year	Sampling Frame
2008	2005-2007 granted patents, three types
2009	2008 granted patents
2010	2009 granted patents; valid patents until the end of 2008
2011	2010 granted patents
2012	2011 granted patents
2013	2012 granted patents

● Patent Holders (2014)


Valid patent holders until the end of 2013

Sample Size




Sample size and recovery rate in 2008 -2013 (granted patents)

● Sampling Coverage decreased from more than 14% in 2008 to 3.5% in 2013.

* *2014 sample size : 18480 patent holders cover 3.3% of the total sampling frame, the recovery rate 82%.*




