### Patents for inventions and commercial secrets

- To consider a way of protection: is it better to make it known as an invention and receive a patent, or protect it as a know-how;
- Specialists of high qualifications in very special mechanisms are required as representatives;
- Local disputes on patents: long and ineffective;
- European support helps to increase the number of applications.
