PHILIPPE BAECHTOLD

Philippe Baechtold, a national of Switzerland, is Director of the Patents and Innovation Division at the World Intellectual Property Organization (WIPO). His area of supervision involves legal questions related to patent law (excluding the PCT), including utility models and semiconductors, and, in particular, the development of international patent law, legal and policy advice in the above areas and extends to work relating to innovation and technology transfer.

Before joining WIPO, Mr. Baechtold has been working at the Swiss Federal Intellectual Property Institute, first as a legal officer in the International Affairs Unit, then as Head of the Patent Law Section, and finally as Acting Head of the Patent Department. As a representative of Switzerland, he has attended expert meetings and negotiations on patent law at WIPO, the European Patent Office and during the WTO TRIPS negotiations. Mr. Baechtold is an attorney-at-law (faculty of law of the University of Berne (Switzerland)).

MARCO M. ALEMAN

Mr. Marco M. Aleman joined the World Intellectual Property Organization (WIPO) in 1999 as a Senior Program Officer working at the Economic Development Bureau for Latin America and the Caribbean. In 2006 he was designated Deputy Director of the Division for Public Policy and Development. Actually is the Deputy Director of the Patent and Innovation Division and Head of the Legislative and Policy Advice Section. Before joining the Organization, Mr. Alemán was a fellow researcher at the Max Planck Institute in Munich, Germany (1998) and Head of the Colombian Industrial Property Office (1995-1998), after having completed five years of private practice on IP matters. Mr. Aleman is the author of two books on IP (Andean Legal Framework on Trademarks, published in 1994 and Colombian National Legislation on Industrial Property, published in 1996) and several articles on IP matters (trademarks, patents, international treaties and conventions, technology transfer, among others). Mr. Aleman received his Law Degree (Javeriana University, Bogotá 1991), Corporate Law Certificate (Javeriana University, 1993); a Master at the University Alcalá de Henares (Madrid, Spain, 2005) where he is currently a Ph.D. candidate.

YE MIN THAN

Mr. Ye Min Than, a national of Myanmar, is Senior Program Officer of the Regional Bureau for Asia and the Pacific of WIPO. Having joined WIPO in early 2002, he is part of the team that formulates, implements and manages technical assistance and capacity building programs for promoting effective use of intellectual property for development in Asia and the Pacific region. Prior to his current position, Mr. Than worked at the United Nations Office at Geneva, Switzerland, for three years and also worked previously at WIPO from 1996 to 1997 at the Office of the Patent Cooperation Treaty (PCT).

Mr. Than holds Bachelor and Master of Arts degrees in International Relations and Law from universities in Switzerland and Myanmar and also an advanced postgraduate diploma in intellectual property law from the University of South Africa (UNISA).

Jose Maria Ochave is Senior Vice President for Business Development & Legal at the United Laboratories, Inc., Mandaluyong City, Metro Manila. He holds a Bachelor of Science in Chemical Engineering (1986) from the University of the Philippines, a Bachelor of Laws (1992) from the University of the Philippines, Diliman, Quezon City, and a Master of Laws (1995) from the University of Michigan.

She was awarded the Sweet & Maxwell Law prize (1981) and the Faculty of Law prize (1983) from the University of London, as well as, the Clough prize (1984) from the University of Cambridge.

Elizabeth has been teaching intellectual property law at the Law Faculty (NUS) since 1986. She also teaches Biotechnology Law and Global Exploitation of IP. She was a consultant to the World Intellectual Property Organization (WIPO) (Geneva, Switzerland) and tutor of WIPO Worldwide Academy. She has also held appointments as visiting scholar to Max Planck Institute of Intellectual Property (Munich, Germany) & US Court of Appeal for the Federal Circuit (Washington DC, US), as well as, Team Leader (ICT section), EAIEL ICT Research Network, University of Hong Kong, among others.

Her most recent publications are "The impact of the bilateral US-Singapore Free Trade Agreement on Singapore's post-TRIPS Patent Regime in the Context of Pharmaceuticals" (2010) *International Trade Law & Regulation*, "Global health and development: patents and public interest" (Chapter 4) in Pogge, Rimmer & Rubenstein, *Incentives for Global Public Health – Patent law an access to essential medicines* (Cambridge University Press, 2010) and "Immoral inventions: Interaction between ethics and biotechnology patent law" (2010) *Singapore Academy of Law Journal*. She regularly gives opinions on IP to public & private sector clients. She is a member of American IP Law Association (AIPLA) and International Association for Advancement of Teaching and Research in IP (ATRIP); and Fellow of the Cambridge Commonwealth Society, University of Cambridge, England.
