1. TheEuropeanPatentOffice(EPO)notesthecommentspreparedbytheInternational Bureauconcernin gthepossiblescenariosforrevisionofthePatentCooperationTreaty(PCT). Itiscertainlyclearthatconsiderationwillhavetobegiventothequestionofmodalities wheneverthefirststageofreform,changeswhichcanbebroughtaboutbyrevisiono fthe PCTRegulations,hascompletedanditisnecessarytoconsideramendmentofthearticles. HoweveritisapparentfromdocumentPCT/R/WG/3/1thattherearemanyoutstandingitems stilltobedealtwithinthefirststageofreformwhichhavenotbeen consideredinanydetail asyetintheWorkingGroup.Theseitemsarelikelytotakesomeconsiderabletimebefore theyaresatisfactorilydealtwithanditisperhapsprematureatthisstagetodevotemuchtime toconsideringthepotentiallydifficultp racticalproblemswhichwouldbeassociatedwitha substantialrevisionoftheTreaty.

2. TheInternationalBureauindicatesquiterightlythattheearlyidentificationofthe intentionsofthememberstateswithrespecttothenatureofpossiblereformi sessential. HowevermuchwilldependontheactualprogressreachedintheWorkingGroupandinthe Committeebeforeitbecomesapparentwhetherweshallhavemodificationswhichare

compatible with the operation of the existing PCT system or whether changes are required which would be incompatible with the current system.

3. ForthesereasonstheEPOwouldsuggestthatwhilelongertermobjectivesshouldbe identified,theWorkingGroupshouldnotconcernitselfatthisstagewiththemodalitiesofa possiblePCTrevision,rathershouldconcentrateontheimmediateworkinhand,i.e. prioritizingthosereformproposalswhichcouldbeimplementedintheshorttomediumterm bywayofchangestotheregulations.
