The Decision Establishing the WIPO Permanent Committee on Patent Information and Dealing with Related Matters, adopted by the WIPO Coordination Committee and the Executive Committee of the Paris Union at their 1977 sessions, provides that the meetings of the PCT Committee for Technical Assistance shall be joint with those of the WIPO Permanent Committee for Development Cooperation Related to Industrial Property. It would seem to be within the intent of the said Decision that the measures contemplated for the future PCT Committee for Technical Assistance (to be established by the PCT Assembly) be applied also to the PCT Interim Committee for Technical Assistance. That is why it is planned that the meetings of the PCT Interim Committee for Technical Assistance will, in its present session, be joint with those of the Permanent Committee. It is suggested that the meetings be presided over by the Chairman of the Permanent Committee, and that therefore no provision need be made in this provisional agenda for the election of officers
