


Patent Prosecution Highway (PPH)





In 2006, JPO proposed the PPH for the first time. In 2019, 50 offices participate in the PPH.


Number of PPH Participating Offices



Note: JPO has PPH partnership with underlined 44 offices




Number of applications examined in PPH in the world





Development of scheme : PCT-PPH


The PCT based on a PCT international work product




High Speed (Reduced Examination Period)

All applications PPH applications (Jan. 2019 – Jun. 2019)




Improved efficiency thanks to work-sharing





- A. Optimized claim scope
- B. Utilization of OEE examination history
- C. Reduction of the number of Office actions





- ✓ The PPH scheme allows the examination of OLE to have at least the same quality of that of OEE.
- ✓ The OLE examiners can learn from the search and examination practices of the OEE through office actions and prior arts.
- ✓ "Claims correspondence" facilitates understanding.






- 1. A copy of all claims and its translation
- 2. Copies of the OEE office actions and their translations
- 3. Copies of all cited documents
- 4. The Claims Correspondence Table

Claims filed with the OLE	Claims determined to be allowable in the OEE	Comments about the correspondence
1	1	Both claims are identical.
2	2	Both claims are identical except for the claim format.
3	1	Claim 3 in the OLE application adds composition A to claim 1 filed with the OEE.




Required documents for the PPH






- At least one corresponding application must exist in the OEE and the appication must have one or more <u>claims determined to be</u> <u>patentable/allowable</u> in <u>the latest office action</u> of the OEE.
- The office action does not always need to be a "Decision to grant a patent." – For example, the office action of JPO includes :

- 1. Decision to grant a patent
- 2. Notification of reasons for refusal
- 3. Decision of refusal
- 4. Appeal decision
