



INTERIM OBSERVATIONS WEB STATISTICS (FEB.-OCT 08)







>> analyze and address the apparent constraints in accessing the ATRs made available through the ATR Management System;

Search solution developed and in place



>> organize the addition of the three modalities of ATRs to search engine indexes (e.g., Google), if possible

- Submission of pages to search engines (July, November)
- Reasonable rankings for key phrases in 4 top search engines in July
- Review and streamlining of metadata in July
- Good rankings for same key phrases in November
