  - 22. The Acting Chair concluded that the SCT requested the Secretariat to re-open the Questionnaire for further replies by May 3, 2023, and update document SCT/43/8 Rev.3 accordingly.

Revised Proposal by the Delegations of Colombia, Ecuador and Peru Concerning Topics for an Information Session on the Protection of Nation Brands in Member States (document SCT/45/6 Rev.3)

- 23. The SCT considered document SCT/45/6 Rev.3.
  - 24. The Acting Chair concluded that the SCT agreed:
  - to hold an information session on nation brands in conjunction with the forty-seventh session of the SCT;

- that the program for the information session would be as follows:
  - (a) Importance of nation brands in the design of public policies and strategies
  - (b) Impact of nation brands on socioeconomic development
  - (c) Experiences on nation brand protection; and
  - (d) Current nation brand protection mechanisms.
- to request the Secretariat to publish the presentations on the WIPO website.

Update on Trademark-Related Aspects of the Domain Name System (DNS) (document SCT/46/3)

25. The SCT considered document SCT/46/3 and requested the Secretariat to keep members informed of future developments in the DNS.
