DIANA AKULLO OGWAL



Diana Akullo Ogwal is a Policy Officer with the Department of Rural Economy and Agriculture of the African Union Commission (AUC). She facilitates policy harmonization, partnership building, and resource mobilization to implement programmes for causing Africa's positive transformation.

Ms. Akullo Ogwal has experience in agricultural policy analysis, formulation, and implementation for improved delivery of scientific knowledge, policy options and technologies at the continental, regional and at country levels. She is interested in contributing to improving women and youth access to key agricultural technologies and inputs for improved livelihoods. She is also engaged in advancing the objectives of the African Union Agenda 2063, which has been elaborated for implementation in the Comprehensive Africa Agriculture Development Programme (CAADP) framework and its related implementation programmes, as well as the Africa Continental Free Trade Area (AfCFTA). Specifically, Ms. Akullo Ogwal coordinates the African Sanitary and Phytosanitary (SPS) and the Geographical Indications Programmes.

Ms. Akullo Ogwal was recently appointed the Regional Coordinator for the African Union and the United Nations Food and Agriculture Organization Technical Cooperation Project on reinforcement of plant health governance in Africa through coordinated management of the Fall Armyworm.

Fatima Amehri is President of AMIGHA (Moroccan Association of the Geographical Indication of Argan Oil) and President of oriGIn Africa (Organization for an International Geographical Indications Network). Ms. Amehri is a former President of oriGIn, representing 500 associations of producers and other GI-related institutions from 40 countries.

Ms. Amehri works as a GI Moroccan national consultant. In that capacity, she has accompanied many Moroccan GIs in elaborating their specifications.

Ms. Amehri has been a frequent speaker in international conferences on GIs (Laos International Conference on GIs; Public Forum organized by WTO in September 2017; INTA's International Conference on GIs in Rome), and has benefited from many trainings on GIs from international experts.

Ms. Amehri holds a University Degree in English Studies from Ibn Zohr University, Agadir, Morocco.

SUSAN ANTHONY



Susan Kathleen Anthony is an Attorney-Advisor in the Office of Policy and International Affairs (OPIA), at the U.S. Patent and Trademark Office (USPTO).

Ms. Anthony joined the USPTO in 2003, where she has handled various portfolios relating to trademarks and copyright, including work within the Internet Corporation for Assigned Names and Numbers (ICANN) and the Internet Governance Forum (IGF).

FRANCIS FAY



Francis Fay is Head of the Unit responsible for geographical indications in DG Agriculture and Rural Development of the European Commission. Mr. Fay has 20 years' experience of policy on geographical indications (GIs), agricultural standards and value-adding schemes, having been involved in more than one reform of EU GI policy.

Mr. Fay has worked on international agricultural trade, and headed the unit for relations with African, the Caribbean and Pacific countries, including negotiations on the agricultural elements of the Economic Partnership Agreements. Previously, Mr. Fay was desk officer responsible for agricultural trade negotiations with the US and Canada, notably on trade in wines and spirit drinks.

He read law at Trinity College, Dublin, Ireland.

DEV. S. GANGJEE



Dr. Dev Gangjee is an Associate Professor at the Oxford Law Faculty and Director of the Oxford Intellectual Property Research Centre. Mr. Gangjee's research focuses on Intellectual Property (IP), with a special emphasis on Branding and Trade Marks, Geographical Indications and Copyright law.

He is the author of *Relocating the Law of Geographical Indications* (2012) and the editor of the *Research Handbook on Intellectual Property and Geographical Indications* (2016). Thematic research interests include the history and political economy of IP, collective and open innovation, and the significance of registration for intangibles.

Mr. Gangjee has acted in an advisory capacity for national governments, law firms, international organisations and the European Commission on IP issues.

ORESTE GERINI



Oreste Gerini is Director of the Directorate General for Prevention and Contrast of Agri-Food Fraud in the Central Inspectorate Department for the Protection of Food Quality and Repression of Agri-Food Products (ICQRF) of the Ministry of Agriculture, Food, Forestry and Tourism Policies (MIPAAFT).

Previously, also within ICQRF, Mr. Gerini was Director of the I/T Office of the ICQRF (Planning and monitoring of the activities of offices and laboratories), of the Conqua I Office (Authorization and Supervision of Control Bodies) and of the ICQRF Territorial Office Tuscany and Umbria.

Mr. Gerini is Professor of "wine legislation" in the degree course in viticulture and oenology at the Department of Agricultural, Food and Agri-Environmental Sciences of the University of Pisa. He was a member of the National Committee for the protection and enhancement of denominations of origin and geographical indications of wines from October 2008 to December 2017. From 2008 to 2011, he was Vice President of the technical evaluation group of the private control bodies and Secretary of the Evaluation Committee of the Control Bodies operating in organic agriculture.

He is a speaker and lecturer in post-university Masters, in numerous courses and seminars on agrifood, as well as in training courses organized by the Administration for the technical staff of the ICQRF.

ALEXANDRA GRAZIOLI



Alexandra Grazioli is currently Director of the Lisbon Registry in the Brands and Designs Sector of the World Intellectual Property Organization (WIPO). Her area of supervision involves the management, development and promotion of the Lisbon System, as well as the development and implementation of projects relating to geographical indications. Since taking up her duties with WIPO in 2014, she has worked as Senior Counsellor and then as Director in the Office of the Director General.

Before joining WIPO, she worked at the Swiss Federal Institute of Intellectual Property first as trademark examiner, then as Senior Legal Advisor, where she was responsible for the coordination of WIPO issues and negotiations on geographical indications. Finally, she worked as Counsellor in charge of intellectual property issues at the Permanent Mission of Switzerland to the United Nations Office and to the Other Organizations in Geneva. As representative and head of the Delegation of Switzerland, she attended several meetings and negotiations in all fields of intellectual property and on issues relating to governance and budgetary issues at WIPO, WTO (TRIPS and Doha Round negotiations).

Ambassador Johnson serves as the Senior International Affairs Advisor for the Consortium for Common Food Names (CCFN). He is also President of Allen F. Johnson & Associates (AFJ) since founding the company in 2005. AFJ has been involved in business and consulting activities in North and South America, Europe, Asia and Africa for companies and trade associations, as well as for the U.S. government and international organizations

Prior to founding AFJ, Mr. Johnson served as an Ambassador at the Office of the United States Trade Representative (USTR) in the Executive Office of the President from April 2001 until September of 2005. At USTR, Mr. Johnson was responsible for directing all U.S. agricultural negotiations globally, regionally and bilaterally, and resolving bilateral issues and disputes, including issues related to new technologies, with virtually every U.S. trading partner. He coordinated closely with U.S. regulatory agencies such as the Department of Agriculture, Environmental Protection Agency, and Food and Drug Administration, in creating federal rules and policies regarding international trade.

Ambassador Johnson has extensive private sector experience in management and marketing in the agriculture and technology sector in the U.S. and abroad. He has served on several boards and is involved in various entrepreneurial and philanthropic activities.

Maslina Malik joined the ASEAN Secretariat in 2018 and is currently a Senior Officer in the Competition, Consumer Protection and IPR Division. She specializes in the area of IPR, with a focus on geographical indications, industrial designs and trademarks, and oversees the ASEAN Working Group on IP Cooperation (AWGIPC) Meetings, which involves participation of the ten ASEAN Member States.

Ms. Malik started her IP career at the Intellectual Property Office of Singapore (IPOS) in 2001. As a Senior Assistant Director in IPOS, she was responsible for the day-to-day operations of the Registry of Designs and Plant Varieties and was involved in carrying out legislative amendments and policy reviews for the registry.

She graduated from the National University of Singapore (NUS) with a bachelor degree in Business Administration.

WOLF MEIER-EWERT



Wolf Meier-Ewert is Counsellor in the Intellectual Property, Government Procurement and Competition Division of the World Trade Organization (WTO), which is responsible for the administration of the Agreement on Trade-related Aspects of Intellectual Property Rights (TRIPS Agreement). In this capacity he gives legal advice in relation to Intellectual Property and the TRIPS Agreement to Members and Observers of the WTO and deals with TRIPS-related dispute settlement cases among WTO Members. He serves as the Secretary to the TRIPS Council, the governing body of the TRIPS Agreement, and to the Special Session of the TRIPS Council, the negotiating group dealing with TRIPS negotiations under the Doha Round. He has widely lectured on TRIPS and WTO-related matters

Mr. Meier-Ewert has practised as an attorney at an international law firm in London and Munich focusing on intellectual property law in international corporate transactions and in cross-border infringement litigation. Before that, Mr. Meier-Ewert was a researcher at the Max-Planck-Institute for Innovation and Competition in Munich, Germany, where he concentrated on copyright law and private international law.

Mr. Meier-Ewert is a graduate of the University of Oxford, UK, where he studied Politics, Philosophy and Economics (PPE) and holds a law degree from the Ludwig-Maximilian University in Munich, Germany.
