1. #### Art-Law Center/Fondation pour le droit de l'art

#### Main objectives of the Organization:

The Art-Law Centre was created in 1991 and is headquartered at the Law School of the University of Geneva. It is organized as a Swiss non-profit foundation (the Art-Law Foundation) which is closely linked to the Law School of the University of Geneva (a formal Center will be created at the Law School in the coming months). A board of trustees, directors, and a scientific committee comprise the Centre' governance. These bodies are composed of representatives from academia, who assure the Centre's scientific activity, as well as of people from the art world, who advise the Centre in its practical orientation.

The goal of the Art-Law Centre is to promote and coordinate research and work on issues relating to art law. For this purpose, the Art-Law Center has chosen an interdisciplinary approach by including people from both the art world and the legal world. The Centre can thus better diffuse its competence and information directly to the public, as well as to specifically interested entities (such as artists, collectors, auction houses, dealers, museums, etc.). Because of the idiosyncratic legal problems that have emerged in the province of art and culture, art law has more and more become a branch of law in and of itself. It encompasses all the aspects of law that are connected with the creation, exhibition, reproduction, sale and transfer of property of works of art and with the protection of tangible and intangible cultural property goods. Art law intersects with different legal fields as varied as international law (both public and private), property law, intellectual property law, intangible and tangible cultural property law, insurance, customs and tax laws.

#### Main activities of the Organization:

The Activities of the Art Law Center are as follows:

A. Conferences

The Centre regularly organizes symposia and seminars regarding current art law topics to which internationally renowned academics and specialists of the art world participate. By inviting specialists from different backgrounds, the Centre achieves its goal of providing a fruitful and interdisciplinary exchange of knowledge through the legal and artistic experiences of both the speakers and the audience. To date, more then twenty symposia have been organized by the Centre. In addition, the Center has co-organized, or been associated with other Swiss and foreign institutions, various events and conferences both in Switzerland and abroad.

### B. Teaching, Research and Publishing Activities

Courses and seminars in art law are given at the Law School of the University of Geneva by one of the Centre's Directors (Prof. Marc-André Renold). The Centre's Directors contribute to various postgraduate programs in Switzerland and abroad in all areas relevant to

art law. The Art-Law Center also conducts research projects at the local and international levels (with other scientific partners) in its fields of scientific interest.

The Centre is the editor of a series of works entitled the "Studies in Art Law", which has come to be used and read as a reference series. The collection includes the papers given at symposia organized by the Centre, as well as books written by specialists. To date, seventeen volumes have been published in the series.

The Centre also publishes the "Art-Law Centre News", a newsletter presenting the latest developments in the world of art law. The Centre is also frequently requested by public and private entities to render legal opinions relating to specific issues of interest in the field of art law and is also offered by Swiss governmental bodies the opportunity to express its opinion on proposals of regulations in the context of the informal consultation process which generally precedes the adoption of regulations in Switzerland.

C. Documentation Center

The Art-Law Centre has put together a documentation centre in the form of a specialized library containing books and documents relating to art law which is located at the Law School of the University of Geneva. This library comprises reference works (in international, comparative and domestic law), specialized periodicals and numerous other documents relevant to the subject.

#### Relationship of the Organization with Intellectual Property Matters:

The Art-Law Center has since its very inception had a strong interest for all intellectual property issues relating to art and tangible and intangible cultural property goods.

As a result of this, the Art-Law Center has become extremely interested by the issues which are discussed in the WIPO Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore (IGC) and most particularly by the interplay between intellectual property, traditional knowledge, genetic resources, and traditional cultural expressions (folklore).

In this context, one of the co-directors of the Art Law Center (Prof. Jacques de Werra) has recently participated in an international conference in New Delhi the topic of which was the interaction between intellectual property rights and the protection of the intangible cultural heritage (in view of the 2003 UNESCO Convention for the Safeguarding of the Intangible Cultural Heritage). This conference confirmed the need for interdisciplinary discussions in order to try to work out solutions to the delicate issues raised by the potential conflicting relationships between different legal fields.

On this basis, the discussion taking place in the IGC is of highest interest to the Art-Law Center given that it raises challenging interdisciplinary issues in the context of the protection of cultural expressions, given that, as emphasized above, the goal of the Center was from its very beginning and still is to adopt an interdisciplinary approach to legal issues arising in the field of art law.

As a result of this, the Art-Law Center is extremely interested by the issues which are discussed in the IGC and would be extremely honored to have the ability to follow closely the discussions taking place in this forum as an *ad hoc* observer.

#### Countries in which the Organization is primarily active:

Mainly Switzerland, but also France and other European countries (through cooperative partnerships with local scientific partners in the context of international cooperation projects, such as for instance the one based on a "*Convention créant un Groupement de recherche international (GDRI)*" in which the Art-Law Center is involved and which is conducted under the leadership of the French *Conseil National de la Recherche Scientifique*, CNRS).

## Public Movement Mezhdurechenskoe Community of Indigenous People "Altin Shore"

### Main objectives of the Organization:

- 1. Protection of the rights of indigenous peoples;
- 2. development and preservation of the traditions, culture, customs of the Shore people;
- 3. preservation of the indigenous lands.

### Main activities of the Organization:

The organization was founded in 1995. Within 5 years, the NGO had been participating in the municipal projects and has been receiving grants so far. The activity is aimed at the remote villages where the indigenous communities live. The organization is composed of 50 staff members. There are 7 activists who work in the field of education, health, culture, environment protection, preservation of indigenous lands and youth involvement.

The information bulletin "Tuganicher" (Native Land) has been published for 15 years and deals with problems of the indigenous people and the solutions to them.

The organization covers different fields of activities: traditional sport team, folklore dancing and singing groups, centers for the studying of the Shore language. Annually, the participants of the public movement "Altin Shore" participate in the regional and municipal activities dedicated to the preservation and development of the culture, folklore, traditions and customs of the Shore people.

Nowadays the organization has established strong relationship with the administration of the city of Mezhdurechensk. Under the mayor of the city is the advisory council on indigenous issues. This council raises and solves problems relating to the social, economic and cultural development. The Regional Department of Culture and National Politics has a short-term social and economic development programme which provides for financial support for the construction of houses, hospitals, etc, and traditional holidays, language and cultural preservation through the publishing of books and text-books in the Shore language.

### Relationship of the Organization with Intellectual Property matters:

The public movement Altin Shore is involved in the preservation of the cultural heritage of the Shore people, in the field of traditional medicine and preservation of biodiversity in the region.

#### Busoga Youth Environment Protection Association (BYEPA)

#### Main objectives of the Organization:

Busoga Youth Environment Protection Association (BYEPA) was established in 1993. It was fundamentally created to address some of the environmental problems in the region of Busoga. Its primary focus was the use of the community, mainly youth, women and the vulnerable groups in the respective districts, actively participate and revitalize environmental awareness, contact possible environmental degradation and issues that had started in other areas of the country. Primarily it was to put both youth and women into some collective thinking and effects, but rather and better to steer them into economic activities (poverty alleviation) within the cooperative background, advocacy for prospective policy(ies) and development.

The front of environmental issues has taken off with increased awareness in the communities and actual enhancement on the ground for instance, re-forestation programme into implementation, knowledge of prosperous health with emphasis on HIV/AIDS, sustainable agricultural farming methods, shelter improvement and income generating to small-scale entrepreneurship. Environmental consciousness has shown slight impact but still needs more efforts in the strengthening of capacity-building and appropriate policy mechanisms.

#### Main activities of the Organization:

- 4. To examine the hygiene situations of rural with suppliers.
- 5. To encourage and empower youth, women into income generating projects.

8. To reduce and minimize the gender imbalance in development and increase the male contributions.

9. Revolving a credit scheme for income generating.

## <u>Center for Peace Building and Poverty Reduction</u> <u>among Indigenous African Peoples (CEPPER)</u>

### Main objectives of the Organization:

1. Rediscovery and promotion of the intellectual and traditional knowledge of the Igbos relating to its traditional medical knowledge and practices;

2. Protection of the masquerade and oracular prophetic practices of the Igbos, Wawa people as they extend in Nigeria, Ghana, Côte d'Ivoire and Senegal;

3. Defense and sustenance of the natural and customary practices of the indigenous African people under the context of foreign religion and globalization which exterminate the population's social and economic existence;

4. Sensitization of the intellectual class in Africa on the issues that border on African intellectual property and folklore;

5. Research and publications on African intellectual and folklore history and issues by collating end reports of conferences and workshops.

6. Poverty reduction programs to ensure environmental and economic sustainability for the Wawas in Igboland spread through the four West African states;

7. Designing relevant programs that will impact positively and contextualize the millennium development goals in the lives and customs of the Wawas in Igboland, especially those in tension soaked Niger delta of Nigeria.

### Main activities of the Organization:

1. We have embarked upon documentation and profiling of the intellectual properties and folklore of the Wawa people of West Africa with a view to seeking legislative and copyright protection of these activities, previously undocumented;

2. Publication of well-researched articles and books on Wawa indigenous people that will itemize the various cultural properties and rights of the people to sensitize the world and national governments on the areas which are threatened with distinction.

3. Organizing workshops and attending global fora of world indigenous peoples to present the perceived areas of injustice and marginalization which have threatened them with extinction and permanent dislocation in the geography of their present locations in West Africa.

4. Collaboration with all other individuals and organizations which promote and defend the intellectual property and folklore of indigenous people worldwide with a view to exchanging information and visits from other parts of the world; 5. Making representation to governments in the four West African countries to recognize and adopt best practices and conventions on world indigenous intellectual rights and properties.

6. Policy advocacy on curriculum change, legal reform and cultural promotion of the intellectual property of the Wawas and Igbos in West Africa.

### Relationship of the Organization with Intellectual Property matters:

CEPPER is interested in the following areas of intellectual property:

1. Documenting and updating of traditional medical practices of the Wawa Igbos in West Africa;

2. Legal reform in West Africa to recognize copyright and patents for individual traditional musicians and herbalists;

3. Government protection of critical sites and environment for the preservation and growth of herbal trees in the Wawa land;

4. Generating proposals and programs that will protect and promote the traditional knowledge of prophecy, folklore and masquerade in West Africa;

5. Lobbying for government's recognition of the human rights of the Wawas and Igbos to poverty reduction and inclusion in the mainstream of affairs in the context of the MDGS.

#### Countries in which the Organization is primarily active:

Nigeria, Ghana, Côte d'Ivoire and Senegal.

#### Additional Information:

1. In the year 2000, a group of twenty catholic priests acting under an overzealous religious inclination went around the twenty towns within Abor, Ukana and Obeleagu Umana, all in Enugu State, Nigeria, destroying all the masquerade houses, artifacts and cultural instruments. They also injured and maimed the Wawa indigenous people who were the traditional worshippers, throwing away all the documented scrolls used in initiation, invocation and prophecy in Wawa land for over a century. Not only were these things burnt, some of the physical representation of the Wawa gods were taken away and hidden in the church at Enugu, the operational base of the reverends who perpetrated this violation against the people are known faces to the Government. The local people were angry and protest was carried which led to Government setting up a probe panel which indicted the priests. The bishop disclaimed their activities. CEPPER was at the heart of the mobilization and sensitization that not only stopped the group but also stopped further violation because CEPPER took them to court to obtain an injunction against their fanatical action against the indigenous people of the Wawas.

2. Nkwo Nnabuchi has been one of the foremost herbalist and folk singer in the Wawa cultural milieu. CEPPER is in the process of documenting native Wawa herbal practices and folklore with his collaboration. The project started in 1999 and is ongoing. CEPPER needs research funding and assistance which Government has promised but is not coming forth.

### Main objectives of the Organization:

LIENIP's activities are directed to improve the abilities of indigenous peoples of the Russian Federation to fully participate in the Russian multicultural society. By these activities LIENIP is striving to diminish discrimination of indigenous peoples in the Russian Federation.

### Main activities of the Organization:

Educational mechanism of LIENIP consists of informational centers, where indigenous interns, selected by their own communities, take internship and learn about indigenous rights and Human Rights at national and international levels. This knowledge is then transferred by the interns to their communities through their teaching activities and publications; thus, multiplying knowledge effect is created.

This knowledge is the first step to create bonds of mutual understanding between indigenous communities and the rest of the world. This understanding will work to diminish conflict potential, help multicultural cooperation within Russian society, enable indigenous people to become functional participants in the democracy building process, break the isolation of the indigenous communities and will, therefore, contribute to ability of indigenous peoples to protect their rights.

## Relationship of the Organization with Intellectual Property matters:

Activities of LIENIP are not limited to instrumental functions of the educational matters. Preservation of indigenous cultures, in particular, Traditional indigenous Knowledge resources, is among the prime responsibilities of LIENIP.

The following matters are considered of the prime concern of LIENIP with Intellectual Property matters:

- lack of a comprehensive, workable mechanism to insure preservation of collective knowledge by international and national law;
- lack of knowledge and educational mechanisms among indigenous peoples on how to protect their knowledge resources from being destroyed;
- a continuous threat of illegal appropriation of Traditional indigenous Knowledge resources by global and national corporations, pharmaceutical companies, and scientific enterprises;
- lack of understanding among the national governmental bodies of the Russian Federation of the importance of preserving Traditional indigenous Knowledge.

Participation in the WIPO Intergovernmental Committee would enhance knowledge of the LIENIP representatives on how to act properly in order to preserve and develop knowledge resources of indigenous communities of the Russian Federation.

The Russian Federation.

### Additional Information:

Traditional indigenous Knowledge is the vital source for the survival of indigenous people with distinct identity. At present, however, illegally inappropriate knowledge resources of indigenous people have gained importance for the most part as resources to influence global economy. To prevent illegal appropriation of knowledge resources of indigenous peoples by the actors of the information market, it is imperative to include representatives of indigenous communities to the global fora on development of laws and mechanisms of protection of intellectual property, where WIPO is the major and most influential one. 1. To protect the remaining tropical forest at Mount Kimangkil, Kalanawan, Sumagaya and Pamalihi ranges within the Ancestral Domain of the Higaonon tribe in accordance with the customary laws and tradition.

2. To seek livelihood assistance from any funding agencies for the marginalized peoples.

3. To secure Certificate of Ancestral Domain Title (CADT) of MAMACILA tribal community ancestral domain.

4. To educate younger generation about indigenous Knowledge System and Practices (IKSP) of the Higaonon tribe.

5. To develop partnership, networking and alliances with government and non-government agencies and other local organizations that support the goal of the association.

### Main activities of the Organization:

1. Seuring Certificate of Ancestral Domain Title (CADT) of the remaining ancestral mountains tropical forest of the Higaonon tribal community to protect the forest from any illegal activities and intruders.

2. Strengthening cultural integrity, indigenous knowledge system and practices, tribal guards and cultural education.

3. Federation building among different tribal communities of the Higaonon ethnic group.

### Relationship of the Organization with Intellectual Property matters:

MAMACILA Higaonon tribal community ancestral mountains have an abundance of natural resources wherein the communities are innocent when somebody gets inside the forest and collects plants for example the buyers of natural forest orchid flowers of different species without free prior and informed consent by the community. It is just one example of what is happening inside the ancestral territory of the Higaonon tribe among any other activities of exploitation carried out by strangers. The community, especially our elders, is afraid of the possible effect of these activities if these are not prohibited. Participating in the Intergovernmental committee would help us be aware of what can be done with people who try to destroy the natural resources in the forest from which we get our daily subsistence (medicine, food, fruit, wild animals, etc.)

## <u>Mannheim Centre for European Social Research/</u> <u>Mannheimer Zentrum für Europäische Sozialforschung (MZES)</u>

### Main objectives of the Organization:

The MZES is an interdisciplinary research institute of the University of Mannheim. In close association with the Department of Social Sciences it has dedicated itself since its founding in 1989 to the investigation of political and societal developments in Europe. Its foci are on comparative research on Europe and an exploration of the European integration process.

The research at the MZES is organized within two research departments and their respective foci.

- A. European societies and their integration
- B. European political systems and their integration.

### Main activities of the Organization:

In its research the MZES concentrates on:

- long-term fundamental research of an interdisciplinary and international nature
- cooperation with similar institutions in Germany and abroad
- the regular convening of international conferences and workshops
- education of young scholars

The research in *Department A* concentrates on the cultural, social, economic and welfare state foundations for the living conditions of the populations in the European countries, as well as on changes in these foundations and the variations among the different societies.

*Department B* links comparative research on the national political systems with research on European integration and international relations. The foci in the first of these two topic areas are political participation, voter behaviour, political parties and electoral systems in the individual European states and their development on the European level. The second topic area examines the political system of the EU and the international embeddedness of European institutions; the institutionalization of international negotiation systems, and the development of a broader European regional system in Eastern Europe.

### Relationship of the Organization with Intellectual Property Matters:

One of the projects the MZES is currently engaged in is "Governance in International Trade: Judicialisation and Positive Integration in the WTO". Positive integration among states, defined as the correction of negative externalities from liberalisation, is generally assumed to be very difficult to achieve on the European level, let alone on the international level. Yet, states have concluded a number of agreements that impose positive obligations to

adopt new policy measures in fields traditionally restricted to the sovereign nation-state. There has been consistent political pressure to graft other, non-trade issues onto the WTO framework, i.e. to enlarge an organisation that formerly dealt exclusively with trade into a governance structure that also has regulatory competences in other areas of public policy.

WTO member states have indeed introduced the obligation to protect intellectual property rights internationally, and they have concluded agreements on health, on technical barriers to trade, and on investment – each of these being fields of public policy for which more specialised agencies within the United Nations system would seem to have been the more natural focus for such agreements.

The hypothesis of the project is that judicialization - the presence of binding third party enforcement - makes WTO commitments more credible. Since it facilitates enforcement, it exerts force on political actors in the legislative arm of the organisation to bring positive integration issues under the jurisdiction of the WTO. The aim of the project is to explore the explanatory force of this general hypothesis in empirical cases of positive integration (intellectual property, health, technical barriers to trade, and investment) and to come to new theoretical and empirical insights about the sources of and conditions for international cooperation.

The interest of the project is however not restricted to the WTO but on the contrary pursues a broader comparative approach looking into activities of other international organizations that deal with positive integration matters. Regarding the case of intellectual property rights, the adoption of the TRIPs agreement in the context of the WTO raises the question of the relationship between the WTO and WIPO. While some IP issues as set forth in a range of international treaties administered by WIPO do fall under the scope of jurisdiction of TRIPs and thus the dispute settlement system of the WTO, for issues such as traditional knowledge and genetic resources the jurisdiction is rather ambiguous or at best unregulated so far. The aim of the project is therefore to further examine the ongoing negotiations regarding these issues and to particularly investigate which role the WIPO plays particularly given the importance some member states attach to the above mentioned judicialized dispute settlement mechanism of the WTO. The ongoing negotiation activities of the WTO but more in particular in WIPO on various intellectual property issues are closely related to the research emphasis of the MZES in general and in particular to that of the above mentioned project. An additional research focus of the MZES is the institutionalization of international negotiation systems; the EU as one of the main actors specifically in the field of intellectual property rights in addition plays an integral part in these multilevel governance systems.
