WIPO/GRTKF/IC/16/1 Prov.2: Draft Agenda for the Sixteenth Session

<u>WIPO/GRTKF/IC/15/6</u>: Proposal of Group B and Group of Central European and Baltic States for Intersessional Working Groups for the Intergovernmental Committee

12. The WIPO General Assembly in September 2009 agreed to renew the mandate of the Committee. The new mandate makes provision for three IWGs to be held in the 2010-2011 biennium. In response to the new mandate, this document entitled "Group B and Group of Central European and Baltic States Proposal for Intersessional Working Groups for the WIPO IGC" was submitted by the Delegation of Switzerland submitted, on behalf of Group B and the Group of Central European and Baltic States, before the fifteenth session. As requested, it was made available as a working document for the fifteenth session of the Committee.
