# RESOURCES AVAILABLE ON THE WIPO TRADITIONAL KNOWLEDGE, TRADITIONAL CULTURAL EXPRESSIONS AND GENETIC RESOURCES WEBSITE

Document prepared by the Secretariat

1. At its Twentieth Session, held from February 14 to 22, 2012, the Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore ("the IGC") invited the Secretariat to produce an information document briefly describing the resources available on the WIPO Traditional Knowledge, Traditional Cultural Expressions and Genetic Resources website ("the WIPO TK website")<sup>1</sup>.

2. Pursuant to that decision, a detailed description of the resources available on the WIPO TK website (http://www.wipo.int/tk/en/) was prepared for all subsequent IGC sessions. The latest version of such description was included in document WIPO/GRTKF/IC/29/INF/9.

3. As indicated in document WIPO/GRTKF/IC/30/INF/8 prepared for the Thirtieth Session of the IGC, this information document would only be issued once a year or when significant amendments have been made to the website.

## The Seminars

9. The mandate of the IGC for the 2016/2017 biennium requested the WIPO Secretariat to organize seminars to "build regional and cross regional knowledge and consensus on issues related to intellectual property and genetic resources, traditional knowledge and traditional cultural expressions with a focus on unresolved issues".

## The Workshops

11. The WIPO Secretariat organized regional and national workshops, aimed at building capacity and raising awareness amongst different stakeholders, and reinforcing national policy dialogues and processes around the interface between intellectual property and genetic resources, traditional knowledge, and traditional cultural expressions. #### **New Resources**

At its Twenty-Ninth Session, the IGC requested the Secretariat to establish "a new webpage consolidating all existing resources on regional, national, local and communities experiences (such as studies, collections of laws, submissions, databases, voluntary codes and protocols, and presentations) prepared by the WIPO Secretariat or submitted by Member States and observers for purposes of the Committee to date".
