WIPO VOLUNTARY FUND FOR ACCREDITED INDIGENOUS AND LOCAL COMMUNITIES: INFORMATION NOTE ON CONTRIBUTIONS AND APPLICATIONS FOR SUPPORT

This document contains information required to be reported to the Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore ("the Committee") on the operation of the Voluntary Fund for Accredited Indigenous and Local Communities ("the Fund"). The rules are set out in the Annex to document WO/GA/32/6, which was approved by the WIPO General Assembly at its Thirty-Second Session in September 2005 and subsequently amended by the General Assembly at its Thirty-Ninth Session in September 2010.

Article 6(f) of the rules states:

- "(f) Before each Committee session, the WIPO Director General will communicate for the information of participants an information note setting out:
 - (i) the level of the voluntary contributions paid into the Fund on the date on which the document was drafted;
 - (ii) the identity of the contributors (unless individual contributors have expressly requested to remain anonymous);
 - (iii) the amount of the resources available taking into account the funds disbursed;
 - (iv) the list of people who have benefited from the Fund's support since the previous information memorandum;
 - (v) the people chosen to benefit from the Fund but who withdrew;
 - (vi) the amount of the support allocated to each beneficiary; and

(vii) a sufficiently detailed description of the applicants seeking support for the following session.

This document will also be addressed by name to the members of the Advisory Board for examination and deliberation."

The present document constitutes the thirty-sixth such information note, as required by the decision of the WIPO General Assembly. The information required to be communicated to the participants in the Forty-Fourth Session of the Committee is as follows:

Insofar the Forty-First Session was concerned, only Group Coordinators were authorized to attend the session physically due to the Covid-19 pandemic situation at that time⁶.

Insofar the Forty-Second session was concerned, due to the Covid-19 pandemic which causes travel restrictions and policies in place, the Fund was unable to grant financial support to the two recommended applicants⁷.

In implementing the recommendation for funding made by the Advisory Board of the Fund regarding the two recommended applicants, the Secretariat understood that the recommendation adopted by the Advisory Board of the Fund at that time was made implicitly with the view to the first of the forthcoming sessions of the Committee that the recommended will be authorized, as Observers, to attend physically, and taking into account the travel restrictions and policies in place due to the Covid-19 pandemic, be able to travel to. Given that both conditions were met in relation to the Forty-Third Session of the Committee, the two recommended applicants have been granted funding, in accordance with the rules of the Fund and pending availability of funds, with the view to the Forty-Third Session.
