Traditional knowledge and associated genetic resources, as the commercial benefit from the use of traditional knowledge and genetic resources is obvious





What for the legal protection of traditional knowledge is needed?



- conservation for the future generations of accumulated knowledge and experience related to the use of biological diversity and genetic resources, which emphasize the uniqueness of the people;

- holders of traditional knowledge should receive fair benefits from use by third parties of their knowledge.





Law " On the Protection of Traditional Knowledge"

CB

Adopted on July 31, 2007, the law regulates the relations connected with the protection and use of traditional knowledge in Kyrgyzstan. The main purpose of the Act is to prevent illegal patenting of traditional knowledge



Law of the Kyrgyz Republic "On protection of Traditional Knowledge





Establishes a legal regime for the protection of traditional knowledge only in the territory of the Kyrgyz Republic;

It does not apply to the objects of folklore and handicraft arts



The legal protection of Traditional Knowledge



- Traditional knowledge may be registered by one or jointly by several natural persons or legal entities who are the holders of traditional knowledge;
- an application for registration of Traditional Knowledge may be applied by the state bodies and institutions;
- foreign natural persons and legal entities in accordance with this Law shall be entitled to carry out their activities through their official representatives.



The legal protection of traditional knowledge



- It does not apply to traditional knowledge that is actually or potentially may harm the life and health of humans and the environment;
- Registration of Traditional Knowledge in the Kyrgyz Republic shall not be limited in time.



State regulation of traditional knowledge





The state policy in the field of traditional knowledge is implemented by State Intellectual Property Service and Innovation under the Government of the Kyrgyz Republic (Kyrgyzpatent)



State regulation of traditional knowledge



- consideration of an application for the registration of traditional knowledge;
- implementation of state registration of traditional knowledge;
- formation of a database on traditional knowledge;
- Republication of information on traditional knowledge;
- development of normative legal acts in the sphere of protection of traditional knowledge.



Consideration of an application for registration of traditional knowledge

Consideration of the application - 3 months

The conclusion on the registration of traditional knowledge

Refusal to register

Granting the certificate



The application must include:



- application for registration;

- conclusion of the competent authority;



Patenting objects that are based on traditional knowledge





- Not allowed patenting of objects representing traditional knowledge;

- When patenting the objects that are based on traditional knowledge in the application materials is required to disclose the origin of traditional knowledge used as a prototype or analog;
