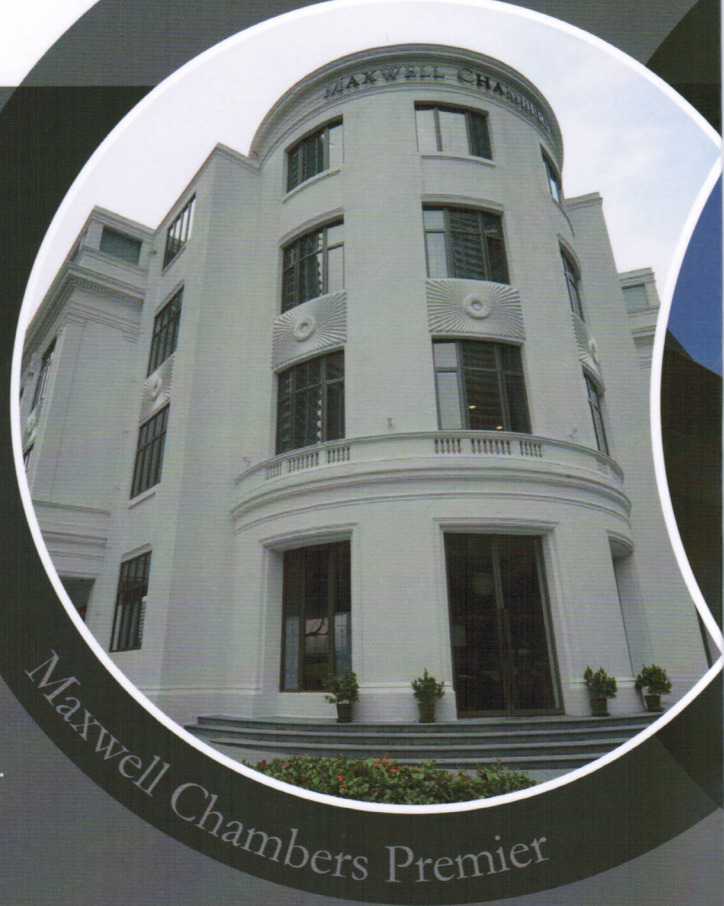

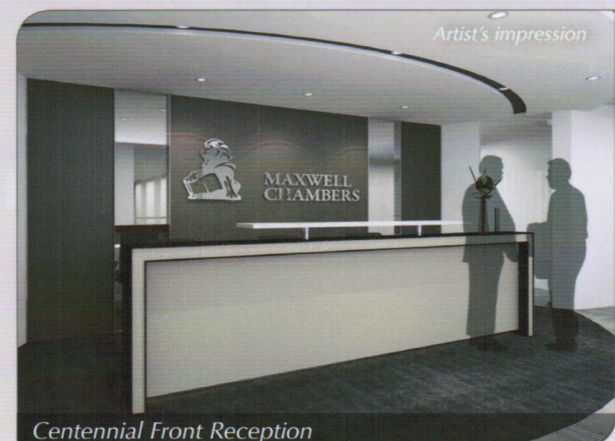

As a party to the New York Convention, arbitration awards of member countries are fully enforceable in Singapore.

Open Arbitration Regime

Singapore's arbitration regime is based on the UNCITRAL Model Law.

Foreign arbitrators have complete freedom to practise arbitration work here. They are also exempted from taxes for income derived from arbitration work done here.

Stable Climate and Extensive Infrastructure

Singapore is the most politically stable country in Asia and has among the lowest crime rates worldwide (IMD World Competitiveness Yearbook 2010, IMD Switzerland).

Draft Arbitration Clause

The following arbitration clause can be incorporated into your contracts in relation to arbitrating disputes in Singapore:-

Disputes

Any dispute arising out of or in connection with this contract, including any question regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration in Singapore in accordance with the Arbitration Rules of the Singapore International Arbitration Centre ("SIAC Rules") for the time being in force, which rules are deemed to be incorporated by reference in this clause.

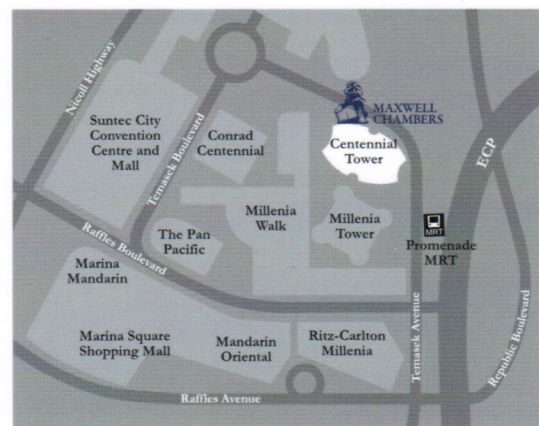
The Tribunal shall consist of (one/three) arbitrator(s) to be appointed by the Chairman of the SIAC.

The language of arbitration shall be in (English).
