**Yes - Applicant submits the images of figurative elements of mark on a drawing documentation in maximum A4 format. The minimum format is 15 x 15 mm (At least one side of the document must be 15 mm) The maximum format of the image is 80 x 80 mm (no image should exceed the extent of 15 x 15 mm. During scanning is the image modified according to standard, so that none of its proportions exceed the size of 70 x 70 mm.**
