The “Recommended Presentation in Abbreviated Form as a Priority Application Number” should be presented with the Standard ST.3 code (preferably in a specified line or column along with the title “The country code (in case of the international organization, ‘The organization code’) and number of your priority application, to be used for filing abroad under the Paris Convention, is”) to be easily recognized as priority number by other IPOs and applicants.

*Example of presentation of “Recommended Presentation in Abbreviated Form as a Priority Application Number”:*

- (ii) in case of the international organization:
