WIPO miyah kah niganikidik weni, win kishka ikado kegoni nitim apitc nigoshkadadowatc IGC ka ijinkazowatc.

Kodik awik ima wi-abitc, kidja pigidinaginitc dish IGC nekenah, odah kishpinehbiyan yeni mizinigani, WIPO nidino, mi-ima ija pidigezinazin, 60 nigokijigik ijisek minigik agwa mishi nigoshkidadowatc IGC ka kijigabidimowatc.
