2. Industrial Design kodik ijinkadeh keh kishka abidjitowiban kidja kinendamin wewendah adi keh ijinagok koni keh ipitigik kagi ojitowin

Ka mishak ojtcigadek (Patents Design ijinkadjigadeh kodigin awesh) minowashik dish koni kinesh keh kinendjigadek, kan nigok agwa minosek, kinoweh eh-ijanagok koni- eh-ijigik miya ka nidinigadek kan win aneh-esek koni etodejigemigik. Industrial Design Rights kah ijinkadegan, takishka abidin ishpin maneh kegon adaweyin, tibindjibizin, napkaginiyabi koni asini abidjic koni actic anikadjigan.
